and administrative law I found that these disciplines rarely inform one another While it is common to acknowledge the long and venerable history of due process scholars and judges ignore its traditional meanings and uses I also found that many of the means by which the Supreme Court has expanded the protection of the due process clauses in the past 100 years are not entirely novel For example due process was used in a substantive way in the Case of Monopolies in 1602 More generally due process has been claimed almost from the beginning as a guarantee that dealings with government will be fair While the Supreme Court has clearly gone beyond any reasonable interpretation of the due process clauses the impetus to use due process to protect rights not included in the Constitution and those foreclosed by narrow interpretations of other clauses is understandable the Abstract
