Remote Desktop Protocol RDP is a proprietary protocol developed by Microsoft which provides a user with a graphical interface to connect to another computer over a network connection. RDP refers to Remote Desktop protocol which connects your remotely connected computers or system over a RDP connected network. RDP gives a graphical interface to a client to be able to associate with another PC system or network. RDP servers are built on Windows OS but can be enabled to other OS as well. The major benefit of a remote desktop connection is being able to connect to your data from anywhere in the world. Your data is in one place that is easy to see and you no longer have to have software installed on your own computer. In simple terms, RDP is a short form of Remote Desktop Protocol. RDP specifies for home windows servers it works as an icon to get in touch with an additional computer system.
