

# TAX REFUND UPDATE AND DIRECT DEPOSIT CHART

## TERMS USED:

NHB - No Hold Bank (Products like NetSpend, Bluebird, GreenDot, Chase or Credit Unions)

PATH Act - Law that requires certain tax refunds to be held until after February 15th

TFI - Traditional Financial Institution

DDO: Direct Deposit Date affected by Federal Holiday

DDO: Direct Deposit Date

**DEPOSIT DATES** are based on the IRS beginning to accept returns on January 23rd, your return being approved by the IRS and a refund being direct deposited to a TFI

- Deposit Dates can be 2 days earlier if using a No Hold Bank (NHB)
- Deposit Dates can be delayed by 3-2 days if you didn't pay filing fees up front and the fees are being deducted from your refund, or you received a refund advance
- Deposit Dates can be affected by Federal Holidays

**FIRST DIRECT DEPOSIT (NOT PATH) on 1/24/23** in the afternoon only if all of the following circumstances apply:

- (1) Return was selected in a TEST BATCH
- (2) IRS approved your return with a refund
- (3) Paid filing fees upfront and they are NOT being deducted from your refund.
- (4) Refund is not subject to the PATH Act.
- (5) Using a NHB
- (6) IRS account is classified to receive daily updates.

**FIRST PATH ACT DIRECT DEPOSIT on 2/16/23** in the afternoon only if all of the following circumstances

- (1) IRS approved your return with a refund
- (2) Paid filing fees upfront and they are NOT being deducted from your refund.
- (3) Using a NHB
- (4) IRS account is classified to receive daily updates.

The Date Accepted in blue is possible but it's not guaranteed.
