Divided into three parts, the first analyses the notion of a universal inalienable right to health care from jurisprudential, anthropological, legal and ethical perspectives. The second part considers the translation of international human rights norms into specific jurisdictional healthcare contexts. With a global perspective, it includes countries with very different legal, economic and social contexts. Finally, the third part summarises the lessons learnt and provides a pathway for future action.
