For many Americans who live at or below the poverty threshold access to healthy foods at a reasonable price is a challenge that often places a strain on already limited resources and may compel them to make food choices that are contrary to current nutritional guidance. To help alleviate this problem the U.S. Department of Agriculture (USDA) administers a number of nutrition assistance programs designed to improve access to healthy foods for low-income individuals and households. The largest of these programs is the Supplemental Nutrition Assistance Program (SNAP), formerly called the Food Stamp Program, which today serves more than 46 million Americans with a program cost in excess of 75 billion annually. The goals of SNAP include raising the level of nutrition among low-income households and maintaining adequate levels of nutrition by increasing the food purchasing power of low-income families. In response to questions about whether there are different ways to define the adequacy of SNAP allotments consistent with the program goals of improving food security and access to a healthy diet, USDA's Food and Nutrition Service (FNS) asked the Institute of Medicine (IOM) to conduct a study to examine the feasibility of defining the adequacy of SNAP allotments specifically the feasibility of establishing an objective evidence-based science-driven definition of the adequacy of SNAP allotments consistent with the program goals of improving food security and access to a healthy diet as well as other relevant dimensions of adequacy and data and analyses needed to support an evidence-based assessment of the adequacy of SNAP allotments.

Supplemental Nutrition Assistance Program: Examining the Evidence to Define Benefit Adequacy reviews the current evidence including the peer-reviewed published literature and peer-reviewed government reports. Although not given equal weight with peer-reviewed publications, some non-peer-reviewed publications from nongovernmental organizations and stakeholder groups also were considered because they provided additional insight into the behavioral aspects of participation in nutrition assistance programs.

In addition to its evidence review, the committee held a data-gathering workshop that tapped a range of expertise relevant to its task.

delivered meals are intended to help address the issue of food insecurity they are typically inadequate to address the needs of food insecure older adults SNAP has enrollment and maintenance procedures that are particularly difficult for older adults to navigate pays out an insufficient amount of money to cover food costs and varies greatly by state Availability of community programs varies by municipality often lacks nutritious foods that are complementary to health conditions common among older adults and can be difficult to access due to a lack of reliable transportation disability or cost Heflin and Harrington Meyer advocate for addressing all the issues that increase older adults risk of food insecurity not just financial barriers They suggest updating food insecurity screening tools to include these factors increasing SNAP benefits and income support for older adults and other policies to help combat food insecurity in older adults Food for Thought highlights the increasingly important issue of food insecurity in old age and lays bare the overlooked challenges faced by food insecure older adults

eligibility to applicants that receive a TANF funded benefit allows states to offer program eligibility under rules that vary from those discussed in this paragraph including an elimination of the asset test If eligible for SNAP an applicant household also undergoes a calculation of its monthly benefit amount or allotment This calculation utilizes the household's net income as well as the maximum allotment a figure that equals the current value of the Thrifty Food Plan TFP The American Recovery and Reinvestment Act had temporarily increased this value this increase ended after October 31 2013 Benefits are issued on an EBT card which operates with a declining balance like a debit card Benefits are not cash may not be accessed at an automatic teller machine and are redeemable only for foods Benefits may be redeemed for foods at licensed retailers which may include a wide variety of retailers so long as retailers meet licensing requirements *An Examination of the Impact of the Supplemental Nutrition Assistance Program on Food Insecurity and Depression Among Low-income Adults Living in the United States* Tess Goldson,2019 Multiple studies have identified the association between food insecurity and mental illness Few studies have examined the impact of participation in the Supplemental Nutrition Assistance Program SNAP on food insecurity and depression among adults living in the United States This study sought out to determine if there is a difference in the association between food insecurity and depression when comparing adults who receive SNAP benefits to those who do not This cross sectional study analyzed data from the 2009 2014 National Health and Nutrition Examination Survey Adult food security status was measured using the 10 item U S Food Security Survey Module depression was measured with the Patient Health Questionnaire PHQ 9 Associations between household food security status and depression were analyzed using multivariable logistic regression Crude and adjusted models were created to examine the relationship between food security and depression in those who receive SNAP benefits and those who do not It was found that 15 9% 17 7% and 15 4% of adults experienced marginal low and very low food security respectively The odds of being depressed were 2 82 times greater for very low food secure adults compared to fully food secure adults AOR 2 82 95% C I 2 27 3 52 Among low food secure adults that receive SNAP benefits the odds of being depressed was 1 89 times greater compared to fully food secure adults AOR 1 89 95% C I 1 20 2 97 The results from this study will be used to close the gap in research regarding the impact of SNAP participation on food security status and depression **Supplemental Nutrition Assistance Program** Erika Joana Carrillo,2021 There are barriers to the Supplemental Nutrition Assistance Program SNAP that aid in higher food insecurity amongst eligible participants and non participants Eligible participants are individuals who meet the eligibility criteria and receive SNAP benefits For this proposal eligible non participants refer to people who cannot receive benefits regardless of their need or income level Their accessibility to food assistance programs is restricted due to program regulations and policies The literature review reflects that social political and environmental challenges that deter participation to SNAP undermining its goal of alleviating food insecurity The research identifies poverty welfare stigma stringent eligibility guidelines public charge and food deserts as current challenges Additionally recent literature suggests
