WHEREAS, both the Parties wish to enter into a written contract in order to enlist the various terms and conditions of the Agreement.

NOW, THEREFORE, the Parties agree as follows:

1. DEFINITIONS

- 1.1. The "Technology" means any and all proprietary processes, inventions, software, hardware, discoveries, technology, equipment, tools, drawings, designs, prototypes, plans, specifications, materials, trade secrets, know-how, standards, documentation, applications, methods, techniques, formulae, protocols, analyses, information and data in any form (whether or not patentable or copyrightable), and any and all other intellectual property or proprietary information, that presently exists or is developed prior to, on or after the date of execution of this Agreement relating in any way to the Licensor's technology.
- 1.2. "Equipment" means the equipment that comprises of the hardware and software Technology invented by the Licensor as specified in Schedule 1, as amended from time to time by the written agreement of the Parties.
