In diesem Zusammenhang ergeben sich die Fragestellungen, worunter die Risikomessung im Risikomanagementprozess einzuordnen ist, welche Ansätze eine geeignete Quantifizierung von Einzel- und Gesamtrisiken ermöglichen und welche Vorschriften seitens der Aufsichtsbehörden im Hinblick auf Risikomessung bestehen. Dafür ist in Kapitel 2 zunächst der Risikobegriff unter aktuellem Verständnis in der allgemeinen Definition und seinen verschiedenen Ausprägungen zu erläutern. Eine Risikomessung geht mit einer vorherigen systematischen Identifizierung und einer anschließenden Steuerung und Überwachung aller Risiken einher. Im Rahmen des aufgeführten Risikomanagementprozesses soll daher unter Kapitel 2.2 der idealtypische Ablauf in einem installierten Risikomanagement einer Bank, einer Versicherung oder eines Wirtschaftsunternehmens aufgezeigt werden. Nicht jede Art von Risiko lässt sich auf dieselbe Art und Weise bewerten. Daher wird eine Unterteilung in verschiedene Risikoarten unter Berücksichtigung von möglichen Risikomessungen in Kapitel 2.3 vorgenommen. Risiken können eingegangen werden, sofern sie transparent und in einer Größe quantifizierbar sind. Für die Risikomessung eignen sich sogenannte Risikomasse, wodurch gewisse Risikoarten quantifiziert und in einem Portfolio aggregiert werden können. Der Value at Risk (VaR) beschreibt dabei ein modernes Risikomaß und gibt Auskunft über eine mögliche Schadenshöhe.
