S - Symptom

Mr. Smith has been more than cooperative for the focus of this treatment. Standard interventions as opened by the treatment team have been well accepted and implemented.

Client reported feeling depressed, but not suicidal, since his last visit and stated "I didn't know if I was well with the public or not." He stated, "I don't believe in treatment, but I'll give it a try as long as I have help with the coverage." He reported trying several different outpatient sites for covering coverage, but stated "I find better living on Medicaid, it makes the coverage more manageable." He reported residual pain from his back condition.

O - Objective

Observations: Client was oriented, supporting the subjective information. This was reflected in the physical appearance of the patient including: clean, cleanable, clean-shaven, clean-cut, well-groomed, well-groomed hair, tidy signs, no sign of intoxication in the patient, and indications the patient is currently taking or being prescribed.

Client was withdrawn and guarded. He participated in group therapy and engaged in the group process with the help of the counselor. He was able to identify his "triggers," such as "feeling the same from my accident" and "feeling around other people who are staff." Withdrawn symptoms have resolved. However, he still has strong coverage despite improvement since starting treatment.

A - Assessment:

Client was good-moderate. Overall, Mr. Doe appears engaged in SUD treatment at this time. He still has strong coverage and is fearful of relapse, but trying to be more outgoing in substance. Client is higher than necessary - will coordinate with substance prescription. He continues to report depressive and pain symptoms and would benefit from the other medical and psychiatric health follow-up, respectively.

P - Plan:

The three main plans serving the need, based on the clinical information reported and the assessment.

Substance Use:

- Client will continue DOP and MAAT as prescribed. He agreed to attend at least 2 Medication Assisted Treatment meetings at least 2 per week. Continue substance and coordinating with substance prescription.
- Counselor will refer the client to case management for help with housing and employment. Admitted.
- Client ongoing depressive symptoms, will refer for mental health assessment.

Physical Health:

- Client will call his PCP to make an appointment for next week.
- Refer to case management to try to ensure the client made PCP appointment.
