Supreme Court Case	Freedom/Restriction	Ruling
Schenck v. United States	Freedom of Speech can be restricted if clear and present danger is apparent.	(1919) The Supreme Court upheld a conviction against Charles Schenck in which he urged resistance to the draft. The court ruled his actions presented a clear and present danger to the enlistment of armed forces during WWI.
Tinker v. Des Moines	Freedom of Speech extended to non-violent, silent protests in school. Symbolic Speech.	(1969) The Tinker children wore black armbands in protest of the Vietnam War. The Court ruled that the school district could not punish the students for merely engaging in symbolic free speech that was not disruptive.
New York Times Company v. United States	Freedom of Press extended.	(1971) The Court ruled that the New York Times and Washington Post could publish the classified Pentagon Papers without threat of punishment or censorship from the government.
Texas v. Johnson	Freedom of Speech extended to flag burning as symbolic speech.	(1989) The Court ruled that Gregory Johnson's act of flag burning was a protected form of free speech under the first amendment.
