*Additionally, there will be a 6% tax and an 18% gratuity added to your total cost.*

It is understood that Chimney Corners is a family resort and requires your event to be finished at 11:00 pm. Any unnecessarily loud or unruly behavior is cause for immediate termination of the event.

Accommodations at the resort requires separate arrangements and deposits and is not included in this agreement.

**Payment Terms:** The wedding couple, or agent of couple, agrees to pay a deposit of \$\_\_\_\_\_. This deposit is non-refundable 60 days prior to event.
